I also understand that Arizona Core Baseball (RNM Enterprise, LLC) will not administer any physical examinations and that Arizona Core Baseball (RNM Enterprise, LLC) will rely solely upon the information shown on the Medical Information & Release form above.

**Camp Waiver / Terms & Conditions**

I, the parent (guardian) of the participating camper, give permission for the named player to receive emergency medical or surgical treatment and hospitalization if necessary. I hereby authorize directors, coaches, staff and associates of Arizona Core Baseball (RNM Enterprise, LLC) to act on my behalf according to their best judgment in any emergency requiring medical or surgical treatment and hospitalization if necessary.

I certify that the named player is physically able to participate in the Arizona Core Baseball (RNM Enterprise, LLC) and that I know of no restrictions, physical impairments, or any other facts, which in any manner limit his/her participation in such a program. I also understand that Arizona Core Baseball (RNM Enterprise, LLC) will administer no physical examinations and that Arizona Core Baseball (RNM Enterprise, LLC) will rely solely upon the information shown on this form. I hereby waive and release Arizona Core Baseball (RNM Enterprise, LLC), and Its Coaches, Staff, Camp Management, Directors, Sponsors and Representatives from any liability for any injury or illness incurred while at camp.

I understand that there is a risk of injury to the named player as a result of camp activities, and knowingly and voluntarily assume risk of such injury.

I will be financially responsible for any medical attention needed during the camp or resulting from an injury received at camp. My medical insurance shall be the insurance coverage for any medical treatment. I further understand Arizona Core Baseball (RNM Enterprise, LLC) retains the right to use, for publicity and advertising, photographs of campers taken at camp.

I also understand and agree that Arizona Core Baseball (RNM Enterprise, LLC) shall not assume, or be responsible or liable for expense, medical treatment, or compensation for any injury the named player may suffer at any time during participation in open swim. I hereby waive and release any and all rights and claims for damages the named player may suffer from, or in any connection with, named player participation in open swim. Named player must follow all posted rules at the pool and understand that swimming is at the risk of named player.

**Payment:** Registration must be paid in full prior to attending camp. Payment can be made in full at time of registration. Deposits will be accepted at time of registration, for the amount specified on the registration form. Final payment of the balance is due 4 weeks prior to the camp start date. Parent / legal guardian agrees to have payment in by that time, or ACB will automatically charge the credit card on file. If final payment is not made, no refund will be given on any deposit.

**Cancellation Policy:** A full camp credit will be issued to you if for any reason you must cancel your Arizona Core Baseball registration. Credit is good for the current season or following camp seasons. Cash refunds are granted only if you have purchased Refund Insurance (see below). Arizona Core Baseball (RNM Enterprise, LLC) reserves the right to cancel a camp for any reason without prior notice. In this case, full refund is given for all monies collected by Arizona Core Baseball (RNM Enterprise, LLC) only. Arizona Core Baseball (RNM Enterprise, LLC) will not be responsible for refunds on airline flights, hotel reservations, or other incidental fees incurred in conjunction with the camp.

**Refund Insurance:** Refund insurance is not included in the camp price. Refund insurance, if desired, must be purchased separately at the time of registration. Refund Insurance entitles you to a full refund of camp fees should you cancel your registration more than 14 days prior to the start of your session. If you cancel within 14 days of your registered session, we will give you a camp credit for all monies paid, valid for 3 years. Credit with insurance is transferable to family members or friends, and good toward all Arizona Core Baseball (RNM Enterprise, LLC) services.

**Limitation of Liability:** I agree that the total cumulative liability of Arizona Core Baseball (RNM Enterprise, LLC), its affiliates and respective directors, officers, employees, and agents with respect to services performed or to be performed by Arizona Core Baseball (RNM Enterprise, LLC), whether for breach of contract, contribution, tort or other theory of liability, shall not exceed 100% of the compensation received by Arizona Core Baseball (RNM Enterprise, LLC), from me pertaining to Player. The parties agree and acknowledge this Section of the Agreement is a material part of the consideration for the Agreement.

**Player's Release of Liability:** I agree to hereby release, forever discharge Arizona Core Baseball (RNM Enterprise, LLC), from any and all claims, debts, costs, obligations, promises, acts, agreements, actions and causes of action, demands, damages, counterclaims, set off, or liabilities (including attorneys' fees and costs), whether past, present, or future, arising from or related to any acts, actions, failures to act, or to any of the matters relating to an injury or other liability resulting from my or Player's disregard or failure to follow Arizona Core Baseball (RNM Enterprise, LLC) rules and etiquette.

**Player's Waiver of General Release:** I, on my own behalf and on behalf of any and all of my guardians, successors, heirs and assigns, expressly waives any and all rights he may have under Civil Code relating to or arising out of my or my child's disregard or failure to follow Arizona Core Baseball (RNM Enterprise, LLC) rules and etiquette. "A general release does not extend to claims which the creditor does not know or suspect to exist in his favor at the time of executing the release, which if known by him must have materially affected his settlement with the debtor."
